Meeting Called to order by Chair Richie Crocker at 6:00 pm

Kendall O asked the commission to purchase a new Printer old one does not work. The computer at this time is being repaired. Motioned by Richie and seconded by Brian that Kendall purchase a printer. Motion carried.

With the missing minute book, Kendall asked Municipal Affairs if the Commission could adopt the notes recorded for by Wendy Watson and Helen Ivens as our minutes. Municipal Affairs granted the request as long as they were transcribed. Having the notes transcribed it was motioned by Richie seconded Brian that we adopt the transcribed minutes as official minutes of the Village of Tiverton. Motion Carried.

Kendall asked if the Commission would consider remunerating Helen Ivens for transcribing her notes for us. After discussions it was motioned by Wendy seconded by Richie that the Commission give Helen \$100.00 for her services. Motion Carried.

Discussion occurred on the Cemetery . Clerk to ask TJ Albright to give the clerk a monthly report on his activities for our records.
