Clerk updated on the Auditor and was told we will have the finished product by end of May of this year, now that the ARO report was finished.

The Ponderosa land has yet to be finalized and Clerk waiting for the Small family to contact him.

Staff asked for a shredder to be purchased for the office. Caitlyn motioned that the village purchase a shredder for the office and for the staff to take care of it,.Wendy Sec. Motion carried.

Oil tank for community hall needs replacing and Chair asked Clerk to secure some quotes.

Smoke & carbon monoxide detectors need replacing in community hall Treasurer volunteered to get pricing and advise village commission at a later date.

Wendy asked if the villages picnic tables could be moved to the location of the land overlooking the harbours parking lot. Will have to get Tiverton Harbour Authorities permission.

Treasurer announced that a \$50.00 donation was made to the village by Kendall & Heather Crocker for using the hall for a family gathering.
