After some consideration on whether to charge a fee to the public for this service. John Motioned that we charge a \$25. charge rate for 50 people or less. Fee will be more if more than 50 people according to the rate charge of the insurers. The Tiverton Super Seniors Rate will be absorbed by the Village. This charge will not take effect til April 1st 2026. Wendy Sec. Motion Carried.

Light for Fire Pond: Clerk had contacted the NSPC about mounting a light by the Fire pond to improve the light at night. Cost to have the light will cost the village \$45 for install and \$ 12.51 per month. Edwin motioned that the village have the light installed. John Sec. Motion Carried
